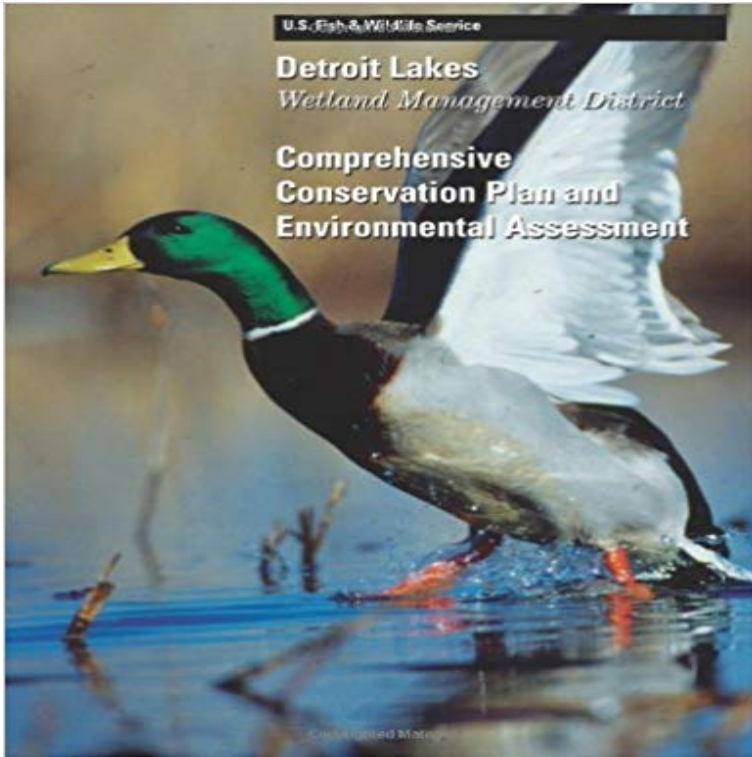


Detroit Lakes Wetland Management District Comprehensive Conservation Plan and Environmental Assessment
