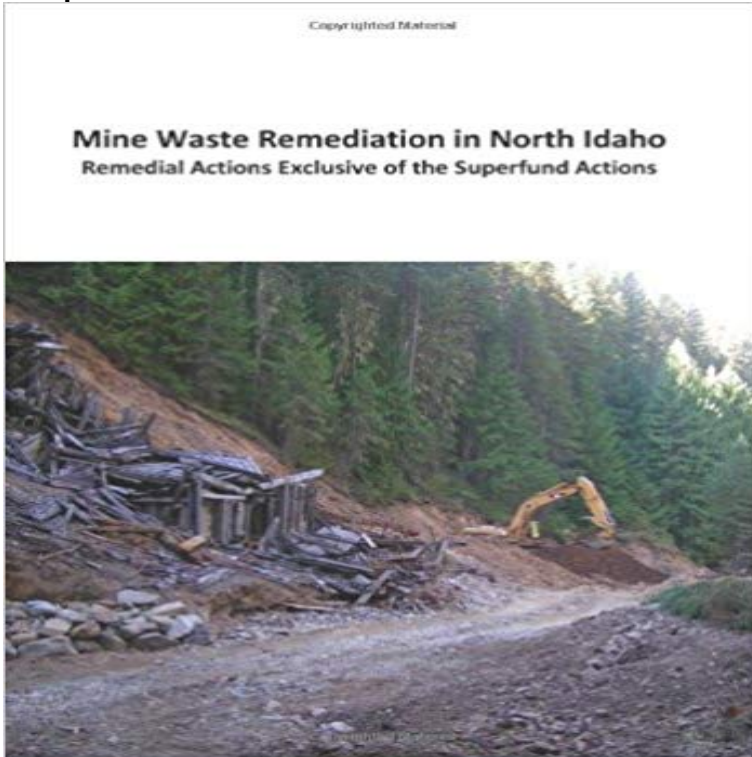


Mine Waste Remediation in North Idaho: Remedial Actions Exclusive of Superfund Actions

The text offers suggestions to those engaged in additional mine waste remediation in this and other areas based on the experience of the work completed to date. The text is written for all inquiring readers with every effort made to explain technical concepts.
