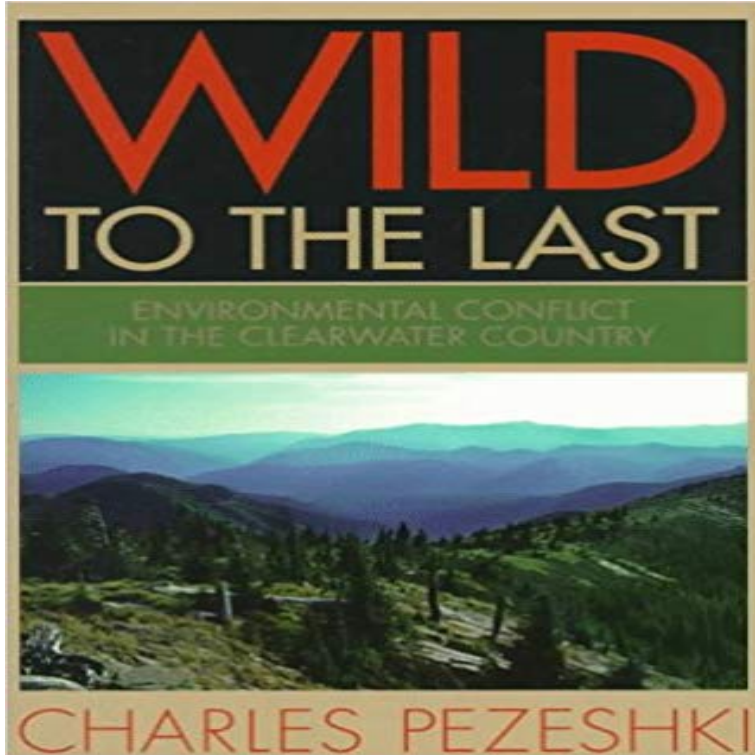


## Wild to the Last: Environmental Conflict in the Clearwater Country
